Dear Parents and Carers,

We continue to take the health and safety of our pupils, parents, and staff very seriously and with the number of positive Covid cases rising in Medway, and the new guidance from the Government in place from tomorrow, we have taken the opportunity to review the activities planned for the remainder of the term.

We are keen for the pupils to take place in as many of the planned activities as possible, but for this to happen as safely as possible, we have had to make some very difficult decisions which we hope you will understand.

- The Christingle service has been cancelled and instead, the Key Stage 2 Carol Service will take place on Friday 3rd December for staff and pupils.
- The Key Stage 1 Nativity and EYFS Nativity will take place on Tuesday 7th December for staff and pupils.

Regrettably, parents and carers will not be able to attend these events. Please be assured this decision has not been taken lightly – we have really enjoyed being able to welcome parents / carers back onto site for the consultations just last week, but we want to do everything within our control to ensure our pupils can participate fully in the end of term celebrations.

Unfortunately, we still have many parents / carers who have not returned the GDPR permissions forms which means we will not be able to record and share these events. Please find attached the GDPR Permissions form which can be completed and returned to the office if you have not yet done so.

Staff will be wearing masks and / or visors and will not be available for discussions at the start and end of the school day.
